# VILLAGE OF INNISFREE MASTER RATES BYLAW 617-16 

## A BY-LAW OF THE VILLAGE OF INNISFREE IN THE PROVINCE OF ALBERTA FOR

 2016 MASTER RATES - FEES AND CHARGESWHEREAS the Council of the Village of Innisfree, in the Province of Alberta considers it necessary to establish one reference for fees and charges for activities and services provided by the municipality.

AND WHEREAS under the provisions of the Municipal Government Act, R.S.A. 2000, Chapter $N-26$, and amendments thereto, the Council of the Village of Innisfree may pass Bylaws and may make provisions that it deems necessary to carry out the purposes of the Bylaw;

AND WHEREAS the addition or amendment of any section of this Master Rates Bylaw shall only affect that particular rate and all other rates shall remain in full force and effect. Should there be an inconsistency between this bylaw and another bylaw adopted on another date, the rates referenced in this bylaw shall supersede.

NOW THEREFORE, be it resolved that the Council of the Village of Innisfree, in the Province of Alberta, does hereby adopt this $\mathbf{2 0 1 6}$ Master Rates - Fees and Charges Bylaw for the Village of Innisfree.

Each separate provision of this Bylaw shall be deemed independent of all other provisions and,
Should any provision of this Bylaw be declared invalid for any reason by a Court of competent jurisdiction, then that provision may be severed and all other provisions of this Bylaw remain valid and enforceable,

All sections attached to this bylaw shall form part of this bylaw.
This bylaw shall come into full force and have effect March $1^{\text {st }}, 2016$ upon the third and final reading thereof.

Bylaw 613-15 is hereby rescinded.
