Community Partnership Grant

West operations have seen daily water flow the through West Transfer Station at twice the volume of the capacity of the reservoir. ACE Water has partnered with the Village of Innisfree and the County of Minburn to review the capacity and the need for additional storage at the West Transfer Station. The grant is up to \$200,000 with no additional cost municipalities. Village of Innisfree will be the managing partner.



Construction Continues

Work continues with several contracts finishing the water transmission lines.



Construction

This year has been a busy construction season. Ace is in the final stages of completing the regional waterline this fall. Construction on the waterline began over 13 years ago, with construction of Phase 1

Generator for West Operations

Ace is in the process of installing a generator to back up operations at the West Transfer Station. When the original grant was for the applied generator not was approved. Since then, Ace was able to secure a generator for the East Treatment Facility as part of the build. Having the west installed generator will complete one of the goals in our emergency management plan.

East Side Operations
Ace is in the process of renewing its 3-year contract for operational services to the east side with the City of Lloydminster. An option for a two-year extension will be added to the contract.

Ace has been working on the following construction sites this year:

- Contract 22 Highway 619 to Paradise Valley
- Contact 23 Blackfoot to 619
- Contract 24 Paradise Valley PRV, Paradise Mechanical, Duvernay Mechanical, Duvernay PRV
- Contract 25 Two Hills to Duvernay.

The contracts are wrapping up and it is our goal to have water flowing to PV and Duvernay near the end of 2023. All construction for Phase 7 must be completed by March of 2024.

New Operators on the West Side

The Town of Vegreville's 3-year full-service contract expired in October of 2022. The Town of Vegreville was not interested in continuing to provide full service to the West Ace operation; however, they did agree to a one-year contract with limited service for ACE. This allowed ACE to review its options moving forward. All options were reviewed, including hiring Ace's own employee's, split contracts, and other municipal service providers. Ace determined the best path forward was a full service provider. The County of Two Hills was selected as the full-service provider and has entered a 5-year contract for servicing the west side operations.
